RA/17/76 Election of Chairman	
Cllr White was proposed as Chairman by Cllr Lawlor, seconded by Cllr Hallisey and Cllr White was elected unanimously on a show of hands.

Top Field footpaths - Rosemary Clarke asked about the meeting between Cllrs Newell & White, together with Phil Allen, met with Sylvia Seeliger and Harry Goodchild (both HCC) on 16 th May. Cllr White presented a map highlighting what had been discussed.	
Decision:	
<ul style="list-style-type: none"> a. <i>PC will put in a Right of Way application for the path extending from the railway bridge at the end of Kim Bishop Walk as well as the route between Springvale Road, up the Woodhams Farm track and then right along the old railway line towards South Wonston (post meeting note, this one already has an existing claim on it)</i> b. <i>Top Field Action Group will put in Right of Way applications for the path from Ilex Close to meet with the Top Field footpath and for the path following the western boundary of SHLAA site 500 north of Woodhams Farm Lane.</i> 	

- c. *It is understood that there is already a claim on the route from Springvale Road (opposite Legion Lane) up towards the Top Field Path (post meeting note – this route does not have a claim on it, so KWPC will claim this one)*

Information on usage needs to be submitted in the next month to support these applications.

Both KWPC and T FAG will advertise all these claims as well as the route around the periphery of Top Field asking for supplementary evidence

Running track at Eversley Park – Malcolm Prince presented two sheets showing plans for a route around the extension of Eversley Park and one around the existing Eversley Park. Joining the two paths together will create a 1630m (one mile route).

Decision:

- (a) *It was agreed that the running route could be extended into the existing park.*
- (b) *It was agreed to permit the placement of wooden marker posts at 100m intervals along the route.*
- (c) *2 councillors will meet with Malcolm Prince and Catherine Haigh (HAB) to finalise the exact details of the route.*

WCC car parking charges – The Clerk commented on the recent increase in parking charges (2-3 hours) at River Park Leisure Centre with this having caused a significant drop-off in the length and number of attendances at the Fitness and Sports Club. The Clerk commented that this appeared to be working against the strategy of encouraging more elderly people to be active.

Decision: *The Clerk is to write to Cllr Prince, copying the letter to the Chief Executive of Energise Me.*
